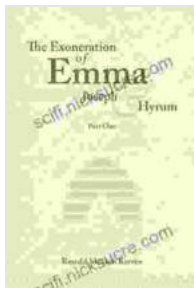

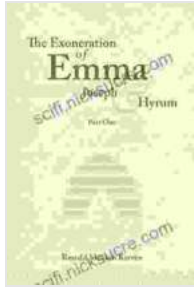

Emma Joseph Hyrum died in 2018 at the age of 66. She was a remarkable woman who never gave up fighting for justice.

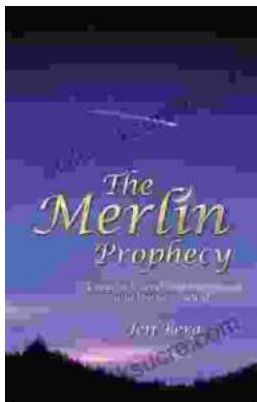

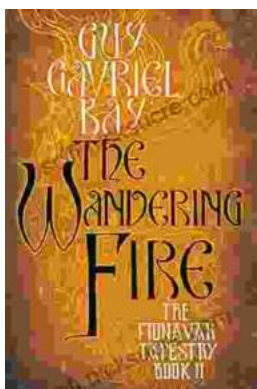
